

FELLOWES CASH BACK PROMOTION

TERMS & CONDITIONS

1. Information on how to claim and cash backs form part of these Terms & Conditions. Claims for this promotion are deemed acceptance of these Terms & Conditions by each claimant.
 - a. Promotion only open to residents of Australia who purchase a Qualifying Fellowes shredder valued at \$100 or over (RRP) from a participating store during the promotional period. The directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies associated with this promotion are ineligible to participate.
2. To claim the cash back, claimants must:
 - a. first, purchase a Qualifying Fellowes shredder valued at \$100 or over (RRP) from a participating store during the promotional period;
 - b. go to www.stopidtheft.com.au, follow the prompts and fully complete and submit the online claim form, which will then be automatically emailed to the entrant's email address submitted; and then
 - c. print the completed claim form and post along with a photocopy of the legible tax receipt, which shows the product was purchased during the promotional period and is valued at \$100 or over (RRP) to **Fellowes Cash Back, PO Box 151, Niddrie VIC 3042**. All required documentation must be sent together in one stamped envelope and received by the Promoter by 5:00pm on 31/10/2009, otherwise the entrant's claim will be deemed invalid.
4. Claimants can only participate in their own name. There are no limits to the number of claims, however, each claim must be lodged with a separate qualifying purchase. Claims received will be considered final by the Promoter. Incomplete, inaccurate, erroneous, ineligible or incomprehensible claims will be deemed invalid. Claims must be received in accordance with the timeframes outlined above, otherwise the claim will be deemed invalid. The Promoter accepts no responsibility for late, lost or misdirected claims.
5. Promotion commences **1/9/2009** and closes **12/10/2009**, and all claims must be received by the Promoter by 5:00pm on **14/11/2009**. Successful claimants will be notified by mail. Unsuccessful claimants will not receive a response. All reasonable steps to notify successful claimants will be taken by the Promoter. The Promoter's decision in relation to all aspects of the promotion is final and no correspondence will be entered into.
6. Each validated claim will each receive the following cheque amount according to the value of the Fellowes shredder purchased (as detailed on the legible tax receipt copy):
 - Fellowes shredder RRP range of \$100 to \$149 will receive a \$15 cheque (including GST)
 - Fellowes shredder RRP range of \$150 to \$299 will receive a \$25 cheque (including GST)
 - Fellowes shredder RRP range of \$300 to \$499 will receive a \$50 cheque (including GST)
 - Fellowes shredder RRP range of \$500 to \$649 will receive a \$75 cheque (including GST)
7. Cheques will be sent within six (6) weeks of the date the claim is validated by the Promoter.
8. The cash backs are not transferable or exchangeable. The cash backs must be taken as offered and cannot be varied. The Promoter accepts no responsibility for any tax implications that may arise from the cash backs. Independent financial advice should be sought.
9. The Promoter reserves the right to verify a claim with the store that issued the relevant purchase receipt.
10. The Promoter reserves the right to request all claimants to produce (within the requested time) appropriate photo identification or other documentation (to the Promoter's satisfaction, at its sole discretion) in order to confirm each claimant's identity, age, residential address and email address, eligibility to claim a cash back and any information submitted by the claimants in entering the promotion, before issuing a cash back. If the documentation required by the Promoter is not received by the Promoter (or its nominated agent) or a claim has not been verified or validated to the Promoter's satisfaction within the time requested, that claim will become invalid.
11. The cash backs will only be awarded following any claimant validation and verification that the Promoter requires in its sole discretion.
12. The Promoter reserves the right to reclaim the cash back from any entrant if Qualifying Fellowes shredder is returned after the claim has been processed and the cash back has been dispatched.

The Promoter and its associated agencies and companies shall not be liable for any loss (including, without limitation, indirect or consequential loss), damage, personal injury or death which is suffered or sustained (including but not limited to that arising from any person's negligence) in connection with using any cash back, except any liability that cannot be excluded by law (in which case that liability is limited to

the minimum allowable by law). The Promoter and its agents associated with this promotion take no responsibility for cheques damaged or lost in transit.

The Promoter reserves the right to verify the validity of claims and reserves the right to disqualify any claimant for tampering with the claim process or for submitting a claim which is not in accordance with these Conditions, or if the claimant is engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
15. The Promoter will not be responsible for any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, this promotion if the deficiency is occasioned by any cause outside the reasonable control of the Promoter.
